Now that I've broken the ice by mentioning money, I need to take that discussion (money) just a little further. While we have a healthy treasurery, it will not be enough to enable us to fund programs, scholarships, research. member services in the future to the extent that we need to. At our recent board meeting we voted on and passed a proposal for a dues increase. This proposal will be brought before the general membership at the membership meeting in Biloxi. The new structure proposed is as follows: Active:

(<100,000/yr) \$50.00

(100-250,000/yr) \$75.00;

(>250,000/yr) \$150.00;

Associate Membership \$100.00/year;

Individual \$25.00/year;

GovAgency/Ed. Free/year.

Student-Free/year.

To go into effect this new structure must be approved by the general membership at the 1996 general membership meeting on January 5 in Biloxi.

Currently dues notices are sent to 480 potential members. Only 280 on the average are returned as paid members. average dues payment these 280 is for \$50.00. If we could collect from all 480 sent out we would increase our collection by \$10,000, which would certainly help. Unfortunately we are not collecting these The board dollars. feels that the increases are necessary, it will be up to the membership on Jan 5, 1996 to let us know if it supports our recommendation. We also need to encourage and reach out to those 200 potential members we are not getting each year. This dues increase will not ensure our economic well being and growth for the future but hopefully will be one step in that direction. We will still need to come up with other methods to raise money and also ways to increase our membership. Don Lobb is chairman of the membership fund raising committee and I am sure he would appreciate any help which you may be able to give him.


these words from Abraham Lincoln might be appropriate.

### A REMINDER Craig Roussel, Director, La Dept of Ag and Forestry

The Louisiana Horticulture Commission amended its rules and regulations to require license numbers to be posted on all business vehicles which carry advertisements signs advertising the business. License numbers may or may not be an integral part of the sign or lettering of the business name. The rules require that the lettering (which may weatherproof adhesive letters and numbers) be at least 2 inches high and legible at a distance of 25 feet and must be displayed on both sides of the vehicle.

If a person is licensed in more than one profession, only one license number is required to be displayed. The number to be displayed should be the license number of the predominant profession and shall be the last four digits of the license number preceded by two letters indicating the type of license as follows:

AR - Arborist LA - Landscape Architect RF - Retail Florist

HS - Horticulturist

LC - Landscape Contractor

WF - Wholesale Florist US - Utility Arborist for example, AR 1234.

The year designation should not be included in the number displayed. Plans are to begin enforcing this requirement January 1, 1996. Until that time, inspectors will be informing licensees during routine inspections.

### Louisiana Association of Nurserymen

#### PROPOSED BY-LAW CHANGES

Current By-Laws

Article 1A. Regular Membership (Active)

Any corporation, partnership, firm or persons engaged in any facet of the green industry or other related business with a definite address and appropriate facilities, having further been actively engaged in the nursery business in a reputable, trustworthy and ethical manner for one year in Louisiana shall be eligible for regular membership. Dues of regular members of the association shall be as follows:

\$0 - 100,000 annual gross sales\$35.00

\$100,000 - \$250,000 annual gross sales \$50.00

\$250,000 + annual gross sales \$100.00

B. Associate Membership

Associate members shall be reputable persons, firms or corporations outside the state of Louisiana actively engaged in the growing and selling of nursery stock, reputable persons, firms or corporations in and out of Louisiana engaged in the supplying of accessories incidental to the nursery business. Dues of associate members shall be \$50.00 per year.

#### C. Affiliate Membership

A person or persons employed in any capacity in any nursery industry or establishment, or allied industry which is a member in good standing of the association, shall be eligible for an affiliate membership. Dues of an affiliate member shall be \$15.00 per year.

#### Proposed By-Law Changes

## Article 1A. Regular Membership (Active)

Any corporation, partnership, firm or persons engaged in any facet of the green industry or other related business with a definite address and appropriate facilities, having further been actively engaged in the nursery business in a reputable, trustworthy and ethical manner for one year in Louisiana shall be eligible for regular membership.

Dues of regular members of the association shall be as follows:

\$0 - 100,000 annual gross sales \$50.00

\$100,000 \$250,000 annual gross sales \$75.00

\$250,000+ annual gross sales \$150.00

#### **B.** Associate Membership

Associate members shall be reputable persons, firms or corporations outside the state of Louisiana actively engaged in the growing and selling of nursery stock, reputable persons, firms or corporations in and out of Louisiana engaged in the supplying of accessories incidental to the nursery business. Dues of associate members of the association shall be \$100.00 per year.

#### C. Affiliate Membership

A person or persons employed in any capacity in any nursery industry or establishment, or allied industry which is a member in good standing of the association, shall be eligible for an affiliate membership. Dues of affiliate members of the association shall be \$25.00 per year.

#### D. Student

Any student actively enrolled on a full-time basis in a Louisiana university and majoring in horticulture or a closely allied field shall be eligible for student membership. Annual dues shall not be charged to student members of the association.

#### F. Government Agency/Educational

Any person actively employed by a government agency or educational institution and having a job responsibility in horticulture or a closely allied field shall be eligible for government agency/educational membership. Annual dues shall not be charged to government agency/educational members of the association.

The 4th biennial Southern Plant Conference, which was held October 12-14, 1995, in Raleigh, NC, presented a forum for some of the horticulture industry's top speakers and leaders to share their expertise with over 570 attendees. The North Carolina Association of Nurserymen (NCAN) and the Southern Nurserymen's Association (SNA) co-sponsored this three-day event held at the North Raleigh Hilton.

This conference, unique to the United States, gives prominent plant experts the opportunity to share plant varieties specific to Southern conditions. An area was provided for speakers and attendees to display new plant cultivars, and new uses for old varieties were also discussed.

Sixteen prominent horticultural speakers shared their knowledge of the industry in their field of expertise: Dr. J.C. Raulston of the NSCU Arboretum in Raleigh, NC; Nancy Goodwin of Montrose Gardens in Hillsborough, NC; Fred Hooks of Post Management in

Atlanta, GA; Dr. August "Gus" de Hertogh of the Department of Horticulture Science in Raleigh, NC; Dr. Michael Dirr of the University of Georgia Horticultural Department in Athens, GA: Dr. Allen Armitage of the University of Georgia Horticultural Department in Athens, GA; Mike Shoup of Antique Rose Emporium in Breham, TX; Patrick Nutt of Longwood Gardens in Pennsylvania: Bob McCartney of Woodlanders Nursery in Aiken, SC; Dr. Richard Lighty of the Mt. Cuba Center in Greenville, DE; Dr. Kim Tripp of Harvard University in Boston, MA; Ruth Dix of the U.S. National Arboretum in Washington, DC: Greg Grant of Lone Star Growers in San Antonio, TX; Scott Reath of Reath's Nursery in Vulcan, MI; Dr. Stephen Spongberg of The Arnold Arboretum in Jamaica Plain, MA: and **Thomas** Dodd, III of Dodd and Dodd Nurseries in Semmes, AL. Sir Christopher Lloyd, a prominent British author and horticulturist, was also available for a special presenta-

tion during the conference at the North Carolina State University Arboretum.

Attendance increased at an unprecedented rate compared to the previous conferences. Up 112%, 572 attendees (compared to 269 attendees in 1993) attended the conference Thursday and Friday, October 12 and 13. While a majority of them took advantage of the North Carolina State University Arboretum tour with Dr. J.C. Raulston on Saturday October 14. many of participants attended the special visit to the Men's Garden Club Flower Show at the NC State Fair Saturday evening.

SNA President Buzz Barton expressed his appreciation to several people who helped with the organization and presentation of the Conference: "This program would not have been so successful had it not been for the hard work and dedication from Don Shadow, J.C. Raulston, Bill Wilder and man others. Obviously, much work went into producing such a successful program."

The 1997 Southern Plant Conference will be held in Houston, TX and will be co-sponsored by the Texas Association of Nurserymen and the Louisiana Association of Nurserymen. The date for the 1977 Southern Plant Conference has not yet been set, but it will be targeted for September or October. Steele Burden a landscape developer and gardener at the Louisiana State University, died June 9 at the age of 95. Mr. Burden who described himself modestly as "just a yard man at LSU," was responsible for developing the LSU campus, City Park and many other public and private gardens in the Baton Rouge area. His family deeded their home and 450 acres known as the Burden Research


Plantation to the LSU Agricultural Center. The property is used by the Horticulture Department and the Cooperative Extension Service for research in greenhouse production, container grown woody ornamentals, herbs, bedding plants - annuals and perennials. Several other university departments participate in turf, fruit and vegetable research. There is an All American Test Rose Display Garden with 1200 rose bushes and 450 varieties at Burden.

Twenty-five acres of botanical gardens named for the family home, Windrush Gardens, are on the property for public viewing. There are several wooded acres registered with the Nature Conservancy, these areas are used as an educational tool by the Forestry Department at LSU as outside classrooms. Also housed on the site in the internationally known Rural Life Museum, an educational resource for LSU. It is opened daily for public visitation.

Mr. Burden always said that we should leave our little spot on earth a bit better for having been here. He certainly did.
